## 5. Weigh-in

- 5.1 **Rules of weigh-in** Service charge for changing of weight classes: EUR 10.00
- 5.2 **Identification** According to the Rules of the German Taekwondo Federation, all competitors need to have a valid.
- 5.3 **Declaration of consent** All competitors who are not 18 years and older at the day of the tournament need a declaration of consent by a legal guardian which must be presented at the weigh in. (see page 5)

## 6. Rules

- 6.1 **Liability** Only members of national federation's affiliation with the ETU are allowed to compete. For countries without any federation being member of the ETU, affiliation with WTF is necessary. Upon registration, the contestants must prove their memberships by means of a valid license.
- All competitors of the International Masters NRW participate at their own risk. The registration application implies that the contestants agree to assume all responsibility for themselves and to release all others from all and any liability which may directly or indirectly result from the International Masters NRW.
- All contestants must bring their own documents and forms for any medical treatment in Germany.
- 6.2 **Coach** One coach for every contestant of the same team is granted free admission with a maximum of four coaches. Only Coaches and competitors have admittance to the competition areas. Coaching is only allowed in sports wear. **All coaches must be 16 years or older. On demand, coaches must be able to verify his/her age by a valid driving license, passport or other official document.**
- 6.3 **Equipment** WTF-recognised trunk protector and head gear and groin, forearm, hand and shin protector which are compulsory, will be brought by the contestants. According to the interpretation of the rules of the DTU/WTF you MUST carry the tooth protector.
- The same body protectors as in the World Championships in Denmark will be used.**
- In case that there will be used electronic body protectors, these protectors will be provided by the North-Rhine Westphalia Taekwondo Union and all other protective equipment must be brought by the contestants.
